- Expand the scope of Center's programs and resources to adapt to new educational requirements
- Organize workshops to retrain teacher trainers in TESOL methodology to meet new internationally set standards
- Invite interested parties to cooperate and set the ground for mutually beneficial business
- Organize activities to raise awareness of the Western educational system and standards among international partners



CRITERIA

1. All participants must be/have:
 - Fluent in English
 - Certified or uncertified teachers or instructors
 - Experience in teaching or employed as such
 - Financially stable and secure
2. All participants must submit registration (non-refundable) fees prior to deadline
3. All participants need to have funds available for their:
 - Round-trip airfare
 - Tuition, room and board (sponsored partially)
 - Meal plans (sponsored partially)
 - Visa processing and red tape
 - Personal expenses

4. “Certified” individuals and groups are those who are certified by Tielc and hold the active status as franchisees.
5. “Uncertified” individuals are those who are not certified by Tielc but agree to acquire the certification upon completion of seminars. “Uncertified” groups are companies, entities, organizations, schools, training centers, etc. which are not in any way affiliated with Tielc but wish to cooperation and participate in the event.
6. All participants are subject to approval as they will have to submit the [Candidate Forms](#) upon registration. Those uncertified who are declined will have their registration fees reimbursed within 30 days from the registration date less nonrefundable \$120.
7. Participants must be able to submit deposit fees upon invoice notification once the registration is confirmed. Deposit fees are used to ensure the commitment of the participant and is 90% refundable in due course in cases:
 - o Visa is declined by the US Consul
 - o Illness or extraordinary situation
 - o Force majeure situations (according to agreement)



RULES:

1. Only certified by Tielc members are charged the registration fees of \$120.00. Those who have never been our certified graduates MUST submit the fees as “Uncertified Individuals” and acquire our certificate prior to arrival or in the process of workshop training.
2. Our franchisees are allowed to submit group registration fees for 5 of their staff members or certified graduates as “Certified Group” members. This does not refer to groups of other than our franchisees – corporations or training centers. They need to submit group registration fees as “Uncertified Group” members.
3. The price for Individual fees “Certified” or “Uncertified” could be submitted depending on quantity of guests arriving. However, we applied discounts on group fees for both Group categories to register their 5-member group as 1 (Qty). Therefore, to avoid erroneous entries, each group of 5 people can choose 1 (Qty) package fee. It is important that this group of 5 people belongs to the same company or entity; e.g. if you have a group of 6 people to send to the event, choose either of Group fees 1(Qty) and Individual fees 1(Qty). It will make 6 in total.
4. Registration fees are not refundable and this is the entry payment to participate in the event.
5. Once the registration fees are submitted, please download the [Candidate Form](#), fill it out (read instructions in the header of the form) and push “Submit” button on the form or print/scan the

form and email it to us at: info@tielc.us using the “Member Registration” in the Subject line of the email.

- Once all above procedures are completed, you will be emailed a link to download your personal or group Invitation Certificate. Those who require the Invitation Certificate mailed out to their physical address, add “Mailing Out Fees” to the registration. For this option do not forget to email your mailing address for the courier mail delivery (FedEx, DHL, USPS, etc.).
